Prof. (Dr) Preeti Misra,, Former Head of Dept. of Human Rights, School for Legal Studies, Babasaheb Bhimrao Ambedkar University (BBAU), Lucknow is Post –graduate in Economics (M.A.) and Law (LL.M.) from Lucknow University. She was awarded LL.D. in Law from the Lucknow University in 2004. She has been Coordinator of Dept of Law, School for Legal Studies Babasaheb Bhimrao Ambedkar University, Lucknow. Prof. Misra has also served as Lecturer in Law Dept. of Sri J.N.P.G. (KKC) College and Part- Time Lecturer in Shia Post Graduate College, Lucknow. She specialized in Criminal Justice Administration and did her LL.D. on ‘Domestic Violence Against Women in India’.

Her research interest lies in the field of women and gender issues, ethnic minority, marginalized sections of society, human rights of rural and urban poor, family violence, aging, education, environment, HIV/AIDS, criminal justice administration, victimology and other development issues concerning Human Rights Law .

She has nearly twenty years of experience in university and college teaching and development fields. She has 129 research articles published in different research journals and books of national and international repute touching upon various aspects of human rights on various social, cultural and developmental issues.
