Minutes of the 5th meeting of the RCA's Advisory Committee held on 19th October 2016 at 3.00 pm in the Board Room, VC Secretariat, BBAU, Lucknow

Agenda No. 1 - University Hostel Rooms for RCA Girls.

Resolution - It has been resolved as RCA Girls may be accommodated in the University's Girls Hostel as other students that there is availability of rooms.

Agenda No. 2 - Seeking permission to transform transit accommodation fund for RCA girls' hostel or any other assets to be appropriate.

Resolution - It has been resolved as University shall approach UGC for seeking permission for the utilisation of the blocked fund under the head Transit accommodation for constructing hostel for RCA Girls, because the University already has made expenditure and accommodated the girls student in the University resources.

Agenda No. 3 - Procurement of Books, study material from Coaching Centre.

Resolution - It has been resolved that the Director, RCA has the authority to procure the required books on priority basis for the benefits of all the concerned students and best performance of RCA.

Agenda No. 4 - NCERT book complete list in two sets.

Resolution – It has been resolved to procure 10 sets of NCERT (10+2) (Hindi and English) books instead of two sets to ensure the availability to maximum students.

Agenda No. 5 - Selection Criteria for resource person for upcoming batch.

Resolution – It has been resolved as the eligibility criteria may be fixed by Director, RCA and selection procedure has to be followed as per University rule. Further, resolutions made in the High Level committee meeting may be adhered.

Agenda No. 6 - Exclusive website for RCA. (Information, prospectus, program schedule, facilities, succeeded students details, faculty profile etc.,).

Resolution - It has been resolved as separate website is not required. The hyperlink may be availed from University website so that the RCA facility in the University should be visible easily to maximum population. Further, the other resources also may be utilise to popularise this facility for the benefits of maximum students of poor community.

Agenda No. 7 -Printing of 500 Prospectus booklets containing Syllabus details and course information for UPSC (Indian Civil Services) Pre & Mains examination.

Resolution – It has been resolved to approve the same and also to consider syllabus for other competitive exams such as SSC, RRB, Banking, etc. The same may be uploaded on the RCA website.
