This practice is in violation of UGC (Minimum Standards and Procedure for Award of M.Phil/Ph.D. degree) Regulations, 2009.

**RESOLUTION**

Academic Council resolved that a letter for reconsideration in this regard may be sent to UGC and MHRD.

**Agenda Item No. 5: To consider the recommendations of the committee constituted to look into the cases of Ph.D. Scholars, namely Ms. Ankita Singh Chauhan, Mr. Pradeep Kumar Singh and Ms. Seema Yadav of DLISc for continuing their Ph.D. after entering into Government Job.**

**Agenda Item No. 8 To consider UGC D.O. Letter no. 3-2/2013 (CPP-II) dated July 15, 2015 regarding use of handloom fabric for ceremonial dresses prescribed for special occasions like convocation, etc by all the universities.**

University has received a UGC D.O. The meeting of the Expert Committee / Adhoc BPGS M.Tech (Computer Science) was held on 27/05/2015. The recommendations of the committee are placed as **Annexure-G** (Page No.32-35) for consideration purposes.

**RESOLUTION**

It was resolved to approve the same. Further, Prof. M.Y. Khan is requested to look into the course structure as per UGC Choice Based Credit System.

**Agenda Item No. 10 To consider nomenclature of the awarding degree of 'Master of Library and Information Science'**

The nomenclature of the degree of 'Master of Library and Information Science' is the same as prescribed in the Gazette of India, No.27, published on July 11, 2014 except the duration of the course, eligibility criteria and last word in degree, 'Science' in place of 'Sciences'. In the list of degrees mentioned on page no. 2989 (Part III-Sec.4) of the Gazette, the duration of the said degree is given one year, and the eligibility for this course is 'Bachelor of Library & Information Science', and the word 'Sciences' is used. The '&' vs 'and' also varies.

Whereas, the Department of Library and Information Science of the University offers Two years, 4 semesters Integrated 'Master of Library and Information Science' and the eligibility of admission in this course is - 'any graduate' with required %. And the 'Science' word is being used in the degree. The offered degree is in consonance of the Curriculum Development Committee (CDC) of University Grants Commission - 2001.

But at the same time, at page no. 2993 of the said Gazette, under the heading 'Guiding principles' the provisions of dual / integrated degrees' are also given. The relevant pages of the CDC of UGC and Gazette are placed as **Annexure-H** (Page No.36-45).

The matter is placed for consideration of the Academic Council.

**RESOLUTION**

It was resolved that Head of the Departments must ensure that all degrees should be as per the UGC Nomenclature. Further, the Department of Library and Information Science may bi-furcate the two years' degree as: 'Bachelor of Library & Information Sciences' and 'Master of Library & Information Sciences'. The duration and admission eligibility must be as UGC notification and university rules. However, the syllabi for these degrees' may be prepared by the respective BPGS/School Board. It may be implemented from academic batch of the year 2015-16.

**Agenda Item No. 11 To consider Academic Calendar for the Academic Year 2015-16**

The Academic Calendar for I<sup>st</sup> / III<sup>rd</sup> / V<sup>th</sup> semester as notified vide notification no. 401/Acad/BBAU/15 dated 14/07/2015 is placed as **Annexure-I** (Page No.46) as reporting item.

Further, regarding the academic calendar for II<sup>nd</sup> / IV<sup>th</sup> / VI<sup>th</sup> the matter is placed before the Academic Council for consideration.

**RESOLUTION**

Further, the Academic Council also approved the draft of Academic Calendar for II/IV/VI semester for Academic Year 2015-16 and all semesters for Academic Year 2016-17 placed before the Academic Council as Table Item.

**Agenda Item No. 12 To consider the amended Eligibility/Qualification of B.Ed. programme for uploading on website /prospectus of the university as reporting item.**

As per National Council for Teacher Education (NCTE) guidelines, the following Eligibility/Qualification has been uploaded/published on the website/Prospectus of the University for Bachelor of Education (B.Ed.) (Two years) programme:

1. Candidates with at least fifty percent marks either in the Bachelor's Degree and/or Master's Degree in Sciences/Social Sciences/Humanity, Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the programme.
2. The reservation for SC/ST/OBC/PWD and other categories shall be as per the rules of the Central Government/State Government, whichever is applicable.

However, administrative approval of Vice Chancellor for amendment at serial no. 2 with regard to reservation as per the university ordinance has been accorded. The matter is placed before the Academic Council as Reporting Item.

**RESOLUTION**

It was resolved that as per Academic Ordinance of the University, BBAU will adopt 50% reservation for SC/ST candidates and the decision be informed to NCTE.



**Agenda Item No. 13 To consider the matter of bi-lingual (English & Hindi) Entrance Examination Question Paper**

A letter has been received from the Nodal Officer, CPGRAMS Portal MHRD, BBAU, Lucknow regarding a Compliant received from MHRD, CPGRAMS website (**Annexure-J1**, Page No.47-48) to conduct entrance examination in Hindi as well as English.

Recommendations of the committee constituted to look into the matter are placed as **Annexure-J2** (Page No.49) for consideration of the Academic Council.

It was resolved to approve for setting of Entrance Examination Question Paper in Bi-Lingual (English & Hindi).

**Agenda Item No. 14 To consider the change in the nomenclature of the MJMC course, L.L.M. (Human Rights), Applied Animal Sciences and other such courses as per UGC nomenclature.**

The BPGS of the Department of Journalism and Mass Communication has recommended changing the nomenclature of the PG course to MA (Journalism and Mass Communication) instead of MJMC as per the guidelines given by the UGC (No. F5-1/2013; The Gazette of India, July 5, 2014). Similarly Head, Department of Human Rights School for Legal Studies has also requested for change in nomenclature of L.L.M. (Human Rights) (**Annexure-K2**, Page No.54). It is also proposed to change the nomenclature of M.Sc. (Applied Animal Sciences) as per UGC nomenclature.

The matter is placed for consideration of the Academic Council.

**Agenda Item No. 15 To consider the matter of L.L.M. (Law) 3rd Semester Fee**

Head, Department of Law, has made a query that fee to be charged from students of L.L.M. (Law) 3rd Semester should be as per fee structure of current academic session or as per the academic session in which they took admission.

It was resolved that revised fee is to be charged only from students who have taken admission in current Academic Session i.e. 2015-16. Further, the students admitted in Academic Session 2014-15 or earlier shall pay fees as prescribed for the respective Academic Session in which the student took admission.

4. It was resolved that the M.C.A (Corporate) running in the department of Computer Science may be renamed as M.C.A (Evening) as per U.G.C Nomenclature.
