At the outset, the Chairman welcomed the members and thereafter agenda items were taken.

After deliberations, following resolutions were passed:-

1. Any Scheduled Caste/ Scheduled Tribes (SC/ST) candidate who has cleared the entrance test in any course in a School may be given admission in other course, if the department of the respective school concerned finds it proper, subject to fulfillment of other required eligibility.
2. Since many seats are vacant in several departments even after completion of admission, the University will have a short term special drive for admission, not only for Scheduled Caste/Schedule Tribe candidates but for all categories and the advertisement in this regard may be released immediately.
 - (i) The department where the seats are vacant, will provide the detailed information to the Admission Coordinator.
 - (ii) The advertisement will specifically indicate that the hostel facility will not be available.

- (iii) The entrance test will be conducted in offline mode and within the University campus.
3. Consequent upon approval of UGC (Minimum Standards and Procedure for award of M.Phil./Ph.D. degree) Regulations, 2016 by the Board of Management of the University, the Academic Council resolved to adopt the same in toto with amendment/modification to be supplemented to these Regulations as and when notified by UGC from time to time. These Regulations shall come into force with immediate effect, i.e. Academic Session 2016-17. It was also decided to adopt the UGC Regulations, 4th amendment, 11th July 2016.

It was also resolved that any amendment/notification issued by UGC from time to time shall stand adopted automatically from the date of issue.

It is further resolved by the Academic Council to start the process of "*held back*" admissions to M.Phil/Ph.D. programmes in light of these Regulations and complete the same by 31st August, 2016 through their respective admission committees/DRCs and the Deans shall be authorized to take final decision.

The meeting ended with a vote of thanks to the Chair.
